4c (Code:) (Expenses \$ 460,725. including grants of \$) (Revenue \$ 1,449,725.) The League provides a variety of programs to member districts. Typically, the League contracts with different vendors to purchase goods and services in bulk, in order to pay lower prices, and then sells these services to the districts. The League earns fees (fixed or percentage) depending on the program and charges participating districts enough to cover administrative costs. Programs currently being offered include electronic databases (library), electricity purchases, tax revenue anticipation notes (TRANS) and policy and procedures services.
