

- More details and information to follow in the coming months.



2019 Budget Act

2019 Budget Act

Proposition 98 Factors

K-14 Appropriations	75,576,046
K-12 Average Daily Attendance	5,960,120
Full-time Equivalent Students	1,125,544
Civilian Population	39,578,945
K-12 Average Daily Attendance (% growth)	-0.04%
Per Capita Personal Income (Test 2) (% growth)	3.69%
Per Capita General Fund plus 0.5% (Test 3) (% growth)	10.00%

2019 Budget Act

Proposition 98:

- Adopts an overall Proposition 98 funding level of \$81.1 billion in 2019-20, \$78.1 billion in 2018-19 and \$75.6 billion in 2017-18, consistent with the Governor's May Revision.
- Provides a payment of \$389 million in Proposition 98 funding into the Public School System Stabilization Account (PSSSA).
- Prohibits the state from making downward adjustments to the Proposition 98 funding level once a fiscal year is over.



2019 Budget Act

For California Community Colleges, the Budget includes **five notable expenditures in the 2019-20 Budget:**

1. A second year of free tuition to first-time full-time students and other local College Promise strategies,
 2. Increased award amounts and expansion of Cal Grant programs,
 3. A buy-down of K-14 PERS and STRS rate increases, and
 4. Proposition 51 expenditures
 5. Changes to the SCFF.

2019 Budget Act

Community College Facilities

- Releases Proposition 51 bond funding
- Approves projects in the Governor's Budget (January)
- Approves projects in the April Finance Letters –
15 new projects and 15 continuing projects
- Also approves 24 new projects and provides 80% of
construction funding for 5 continuing projects



2019 Budget Act

Changes to the **Student Centered Funding Formula**

- Maintains 70-20-10 split for 2019-20 and adjusts for COLA and formula factors moving forward.
- Modifies the definition of a transfer student (12 or more units in the year prior to transfer).
- Extends the hold harmless period by one year, through 2021-22.
- Requires colleges to use three-year averages for outcomes funding
- Counts only the highest of all awards a student earned in the same year.
- Charges the Chancellor's Office with determining the final funding rates for 2019-20 consistent with changes.



2019 Budget Act

Expansion of College Promise.

- The Budget Act expands the California College Promise (Assembly Bill 19 of 2017, Santiago) to provide funding for a second year of fee waivers for all first-time, full-time students.
- Allocates a \$42.6 million augmentation
- Total program at \$83 million ongoing Prop 98



2019 Budget Act

Cal Grant Expansion.

The budget expands the number of competitive Cal Grant awards to allow the state to serve 15,000 more students.

These awards go primarily to community college students.



2019 Budget Act

Deferred Maintenance

Approves \$13.5 million one-time Proposition 98 General Fund to support deferred maintenance projects.

Mental Health

Provides \$7 million one-time Proposition 63 state administration fund to support student mental health services.



2019 Budget Act

Relief on Pension Costs.

The Budget Act makes over \$4 billion of supplemental payments on the state's share of CalPERS and CalSTRS pension liabilities.

- Approves \$3.15 billion (non-Proposition 98 General Fund, one-time) to help school and community college districts with their CalSTRS and CalPERS pension costs.



2019 Budget Act

Longitudinal Data System

Funding to plan a new statewide longitudinal data system connecting information from education providers, employers, and workforce and health and human service agencies.

- Establishes the California Cradle-to-Career Data System Workgroup to the following:
 - (1) Assess and recommend structural components, processes, and options for expansion and enhancement of data system functionality.
 - (2) Advise ongoing efforts to develop, administer, and enhance the data system.



Sponsored Legislation



Sponsored Legislation

AB 30 (Holden): Would streamline the current process to enter into CCAP dual enrollment partnerships with K-12 districts.

AB 612 (Weber): Statewide MOU between Chancellor's Office and State Department of Social Services to enable access to CalFresh/EBT on campus.

Both bills **PASSED** out of the Senate Education Committee with no "No" votes and are in the Senate Appropriation Committee

SB 291 (Leyva): Legislation to reform state's system of financial aid for community college students.

Now a 2-year bill. Senator Leyva, Assemblymember Medina, and Assemblymember McCarty have pledged to work together to identify strategies to address the total cost of attendance and reform financial aid .

Bills of Interest

Berman Parking Lots:

AB 302 (Berman) Requires colleges to permit homeless students to sleep in their cars. Took amendments that exempted colleges that provided all of the following:

- Emergency grants.
- Hotel vouchers.
- Rapid rehousing referral services

Additionally the legislation took amendments indemnifying districts and stating that student participation is at their own risk.

PASSED out of the Senate Education and Judiciary Committees.



Bills of Interest

Athletics

SB 206 (Skinner) Legislation that would permit student athletes to earn income based off of endorsement deals. **PASSED** out of Assembly Higher Ed with amendments taking community colleges out of the bill.

Employee Relations

AB 500 (Gonzalez) Mandates that colleges provide at least six weeks of paid maternity leave. **PASSED** out of the Senate Education Committee with bipartisan support.

Instructional Service Agreements:

AB 720 (Muratsuchi) Permits courses offered pursuant to an instructional service agreement with a public safety agency to be funded based on a general apportionment rate. **PASSED** out of the Senate Education Committee.



Bills of Interest

Facilities:

AB 48 (O'Donnell) Authorizes K-14 general obligation bond for the 2020 primary and 2022 general election ballots. **PASSED** out of the Senate Education Committee.

Faculty Obligation Number:

SB 777 (Rubio) Would have created a formula that would mandate the hiring of full time faculty. **HELD** in the Assembly Higher Education Committee.



Bills of Interest

Non-Credit Programs:

AB 1727 (Weber) Would permit non-credit programs to capture apportionment based on census day attendance accounting rules. **PASSED** out of the Senate Education Committee.

Taxation:

SB 468 (Jackson) Would create a tax review board to evaluate major tax expenditures that cost the state's general fund at least \$1 billion in the last 10 years. The review board would be charged with determining if these tax expenditures were worth the cost to the state's general fund and recommend any changes to state tax code to the state legislature. **PASSED** out of the Assembly Revenue and Taxation Committee.



Bills of Interest

Public Agency Associations:

AB 315 (Garcia) Would prohibit associations that represent local governments from expending public dollars on anything other than educational or lobbying activities, require public disclosure of how those funds are spent and prohibit reimbursement of member travel except to or from conferences. A recent "gut and amend", will be heard in January.

Sexual Assault and Harassment:

SB 493 (Jackson) Mandated policies and procedures as they relate to sexual assault and violence investigations. **PASSED** out of the Senate Judiciary Committee with problematic provisions permitting a private right of action.



Federal Issues



Department of Education

Repeal of Gainful Employment Regulations

- Department of Education announced final repeal of gainful employment protections.
- Consumer protections for students in career programs.
- Required graduates of career programs to earn enough income to pay back loans.
- Takes effect in July 2020.
- Attempts to implement gainful employment regulations at the state level stalled.
